ARTICLES OF INCORPORATION . OF THE BAVARIAN CONDOMINIUM ASSOCIATION

The undersigned, acting as incorporator of the Bavarian Condominium Association, hereby certifies the following Articles of Incorporation for said nonprofit corporation.

ARTICLE I

NAME

The name of the corporation hereinafter shall be BAVARIAN CONDOMINIUM ASSOCIATION, hereinafter called the Association.

ARTICLE II

PURPOSES

The purpose for which the Association is organized pursuant to the Colorado Common Interest Ownership Act (Section 38-33.3-101, et seq., C.R.S. 1973, as amended) and the Colorado Nonprofit Corporation Act (Section 7-20-101. et seq., as amended) is to create a nonprofit corporation entity to operate and maintain the Bavarian Condominiums, a condominium project, located on a parcel of land situate in Pitkin County, Colorado, as described on the plat for such property and recorded in the real property records of Pitkin County, Colorado.

ARTICLE III

PERIOD OF DURATION

The Association's existence shall be perpetual, unless formulated sooner under provisions of the Bavarian Condominiums Declaration (hersinafter "Declaration") and/or the Bavarian Condominium Association Dy-Laws (horninafter "By-Laws").

ARTICLE IV

POWERS

- 1. The Association shall have all of the common law and statutory powers of a nonprofit corporation which are not in conflict with the terms of these Articles.
- 2. The Association shall have all of the powers and duties set forth in the Colorado Common interest Ownership Act except as limited by these Articles and the Condominium Declaration for the Bavarian Condominiums, and all of the powers and duties reasonably necessary to operate the Bavatlan Condominiums as set forth in the Declaration and as it may be amended from time to time, including, but not limited to, the following:

- (a) To make and collect assessments against members to defray the costs, expenses and losses of the Bavarian Condominiums.
- (b) To use the proceeds of assessments in the exercise of its powers and duties.
- (c) To maintain, repair, replace, and operate the condominium property.
- (d) To purchase insurance upon the Bavadan Condominiums properly and protection for the Association and its mambers as provided by the Declaration and By-Laws.
- (e) To reconstruct improvements after casualty and to further improve the property.
- (f) To roake and amond reasonable rules and regulations respecting the use of the property in the Bavarian Condominiums.
- (g) 'In entirize by legal means the provisions of the Colorado Common Interest Ownership Act, the Declaration, these Articles, the By-Laws of the Association, and the rules and regulations for the use of the Bavarian Condominium property.
- (h) To contract for the management of the Bavarian Condominiums and to delegate to such managing agent all powers and duties of the Association except as such are specifically required by the Declaration to have approval of the Board of Directors or the membership of the Association.
- (i) To employ personnel to perform the convices required for proper operation of the Bavarian Condominiums
- (1) To collect delinquent assessments by suft or otherwise and to enjoin or seek damages from an owner as is provided in the Declaration and By-Laws.
- (k) To protect and defined in the name of the Association any part or all of the condominium project from loss and damages by suit or otherwise
- (I) To borrow funds in order to pay for an expenditure or outlays required pursuant to authority granted by provisions of the Declaration and By-Laws, and to execute all such instruments (evidencing such indebtedness) deemed necessary.
- (in) To exceed continues to carry out the duries and powers of the Association.
- (n) In general, to carry on the administration of the Association and to do all those things necessary and reasonable in order to carry out the governing and the operation of the Bavarian Condominiums.

ARTICLE V

MEMBERS OF THE ASSOCIATION

- The members of the Association shall consist of all record owners of condominium units of the Bavarian Condominiums.
- 2. Change of membership of the Amazintian shall be affected and established by the recording in the public records of Pitkin County, Colorado, of a deed or other instrument establishing a record title to a condominum unit to the Bayanan Condominums and the delivery to the Association of any notice of change in ownership as may be required by the Declaration or By-Luws. The membership of the prior owner shall thereby by terminated.
- 3. The share of a member in the funds and assets of the Association cannot be assigned, hypotherated, or transferred in any manner except as an apputtenance to his condominium unit.
- 4. The members of the Association shall exercise voting rights appartenant to each condomination unit owned by them. The exact number of votes to be east by severe of a condomination unit and the manner of exercising voters rights shall be determined by the Declaration and By-Laws of the Association

ARTICLE YI

EXECUTIVE BOARD

- 1. The affairs of the Association will be managed by an Executive Board consisting of the number of Members as shall be determined by the Declaration and By-Laws, but not less than three (3) Directors, and in the absence of such determination shall consist of three (3) Directors.
- 2. Members of the Executive Board of the Association shall be elected at the annual meeting of the members in the manner determined by the By-Laws. Directors may be removed and vacancies on the Board of Directors shall be filled in the manner provided by the By-Laws.
- 3. The initial Executive Board shall consist of three (3) Directors who shall hold office until their successors are elected and have qualified, or until removed. The initial members of the Executive Board are the following: Scott Writer, Frank Goldsmith and Todd Emerson.

NONPROFIT ASSOCIATION

The Association is not organized for profit. No member, member of the Board of Directors, officer or person from whom the Association may receive any property or funds shall receive or shall be lawfully emitted to receive any pecuniary profit from the operation thereof, and in no event shall any part of the funds or assets of the Association be paid as salary or compensation to, or distributed to, or intuo to the benefit of any member of the Executive Board, officer or member, provided, however, always: a) that reasonable compensation may be paid to any member, Director or officer while acting as an agent or employee of the Association for services rendered in effecting one or more of the purposes of the Association; and b) that any a member, Director or officer may, from time to time, be reimbursed for his actual and reasonable expenses inclined in connection with the administration of the affairs of the Association.

INDEMNIFICATION

- Except as provided below, any person made a party to a proceeding because the person is or was a 1. director or an officer of the Association, shall be indemnified against any and all liability incurred in the proceeding, if: a) the person conducted himself in good faith; b) the person reasonably believed: (i) in the case of conduct in an official capacity with the Association, that his conduct was in the Association's best interest, and (ii) in all other cases, that his conduct was at least not opposed to the Associations best interests; and c) in the case of any criminal properting, the person had no reasonable cause to believe his conduct was unlawful. Determination of a proceeding by judgment, order, softlement, conviction or upon a plas of noto contenders or its equivalent is not, of itself, determinative that the person did not meet the standard of conduct described in this section. Notwithstanding the foregoing, the Association shall not indemnify a director under this section: a) in connection with a proceeding by or in the right of the Association in which the person was aljudged liable to the Association; or, b) in connection with any other proceedings charging that the person derived an improper personal henefit, whether or not involving an action in an official capacity, in which proceeding the person was adjudged liable on the basis that he derived an improper personal benefit In this case, indemnification is limited to reasonable expenses incurred by such person in connection with the proceeding.
- No director or officer shall be personally liable for any injury to any person or property arising out of a fort committed by an employee, unless such director or officer was personally involved to the situation giving rise to the littgation or unless such director or officer committed a criminal offense in connection with such situation. The protection afforded in this paragraph shall not restrict other common law protections and rights that a director or officer may have. Nothing become shall restrict the Association's right to climinate or limit the personal liability of a director to the Association, or to its members for monetary damages for breach of fiduciary duty as a director as provided in Arti-cle IV, paragraph 2(0).

ARTICLE, XI

BY-LAWS

The first By-Laws of the Association shall be adopted by the Board of Directors, and may be altered, amended or received in the manner provided by the Declaration or By-Laws.

ARTICLE XII

<u>DISSOLUTION AND LIQUIDATION</u>

Upon dissolution of the Association, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the Association, adopt a plan for the distribution of the assets of the Association consistent with the Declaration and the Colorado Nonprofit Corporation Act.
